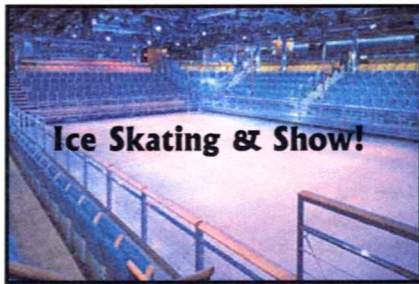

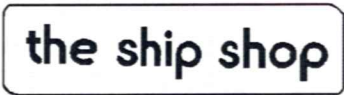
Final Payment: Aug 1/09

Cancellation Penalty: If cancelled after deposit and before Aug 1/09 fee of \$100.pp; Aug 2-Sep 2//09 fee of \$400.pp; Sep 3-18/09 fee of 75% of total fare; No refunds after Sep 18/09.
